INSTRUCTIONS: Scholarship available to **only** Michigan residents who are attending high school or college – no bachelors degree, who are a son, daughter, grandchild or great-grandchild of a war-time veteran planning to or are attending any nationally accredited college or university. Selection is based on a student’s G.P.A. of 2.5 or higher, financial need, parent’s or grandparent’s honorable active war-time military service, goals and intentions. Submit this scholarship form along with requested information to the American Legion’s District Commander found below by the **deadline date of January 8, 2018 (not postmarked by)**. The scholarship award amount is \$500 and not renewable (scholarship winners will be notified by email address).
