

## **PERMANENT TIME AND PLACE COMMITTEE MEETING**

The meeting of the Permanent Time and Place Committee was called to order by Chairman Roger Webster at 2:00 p.m. at the Troy Marriott Hotel in Troy, Michigan.

### **NEW BUSINESS:**

Discussed Resolution 11-F-1 – Appreciation to Conference Committee, 11-F-2 – Memorial to Charles Head, and 11-F-3 – Memorial to Sal Scarpace. Motion by Skinner, seconded by Hafeman, to accept these three resolutions. Motion carried.

Gary Sammons discussed his contract with Heritage Publishing. He will not sign another 3 year renewal until Bill Hafeman talks to the U.P. Conference Corporation at their meeting next month.

Gary Sammons submitted a bid letter for the 2014 Department Convention at the Holiday Inn in Livonia for \$84 per night.

Gerald Dennis submitted a bid for the 2014 Department Convention at the Amway Grand Plaza Hotel in Grand Rapids for \$109 per night.


