Brian Mohlman made a motion, Seconded by Richard Dubay, to accept the bid for the Sheraton Grand Rapid Airport. The motion passed unanimously.

20 North Corporation spoke about a slight increase in the room rate at Tree Top for Fall Conference '26

Genesee County Corporation spoke about future bids in Port Huron for the Fall Conferences in '28, '29, '30.

State Convention

Brian Mohlman spoke about the ~~Fall Conference~~ 2026, that the Doubletree in Battle creek will drop the \$5 parking fee but will include it in the room rates and may increase the room rates by a few dollars.

A motion was made by Brian Mohlman and seconded by Dan Cooper to allow all Convention Corporations a \$15 variance in room rates after being approve and accepted by the committee. The motion passed unanimously.
