While the year is winding down, we still have some exciting events left to go. The Boys State program is in June, and we are asking each Post to send two boys to this nationally acclaimed curriculum. Let's not forget Student Trooper and the many other programs the American Legion offers.

I want to thank everyone for their efforts in our programs. I am aware of what you are doing, and it shows. The reports at the District meetings are very informative. I also know your road this year has not been smooth, but you have kept moving and fighting. Thank you.

Membership is still on the front burner. We failed to meet our national target for April, and our momentum has slowed. We have fallen from 5th to 8th place nationally; however, we are still on the hunt. I am asking every post to help the Department meet our membership goal of 100% this month, which we only need 7.5%. We can do this!

I am also asking every Post for one more very important thing. We really need every Post in the Department to fill out a Consolidated Post Report to ensure that when we go to Washington next year and sit in the hearing with our National Commander, we want to be able to give Congress correct and current information on how much we do to accomplish the core objectives of the Legion. These are not hard forms to fill out. Fill one out even if your Post does not do much. Every hour, every dollar spent, and each time you did anything in your community, put it down. It all counts for something. If you have a question or need help, please reach out to the Department. We are here to help.

In closing, thank you to everyone who attended the wonderful Department Testimonial Dinner last month.

In this edition of Runyan's Ramblings I wanted to bring some great information to all the veterans who have VA benefits and make sure spouses know these benefits as well. I am also a new recipient of VA benefits and had no idea what other benefits I had besides those from the VA. I encourage you to review the list provided to me by our outstanding Veteran Service Officers here in Michigan! Keep up the GREAT work you all do every day for us!!!

Federal Benefits and Healthcare Benefits Available

Veteran Benefits Based on VA Disbility Ratings (0% - 100%)

0%-20%

- Monthly Compensation
- VA-backed home loan eligibility
- Basic burial allowance
- -Limited VA Healthcare services for service-connected conditions (See Priority Groups)
- 5-point Veteran preference for federal jobs

30%-40%

- Monthly Compensation to include dependents
- •Travel Pay for VA healthcare related to service-connected disabilities
- Access to additional services within priority group 2 (See Priority Groups)

50%-60%

- No-cost VA inpatient/outpatient care and prescriptions (See Priority Groups)
- VA home loan fee waiver
- Concurrent Retirement Disability Compensation (CRDP) eligibility
- Commissary, exchanges, and MWR access

70%-90%

- Veteran Readiness and Employment (VR&E) support
- Dependent Educational Assistance (DEA) for children and spouses (under TDIU)

Members should never walk or reach the area between the colors when posted. This is considered sacred ground and Should never be violated.

MVH Chesterfield has been open a little over 4 years, serving our Veterans in the Metro Detroit area (Macomb, Oakland and Wayne Counties). There are 118 residents of a possible 128. The facility offers Veterans short-term and long-term care, rehabilitation therapy, dementia, memory and palliative care. For many, this place is called "home".

I want to express my deepest appreciation to all of you for supporting our work in the Auxiliary for our Veterans! There have been monetary donations, gift cards, goodies, and even handmade items like blankets. The facility is very thankful for the large ticket items that were approved during the Winter Meeting and Fall Conference.

From the friendly staff to soft-hearted volunteers, the Veterans are full of smiles when we are on-site making deliveries, helping with activities or hosting parties. To say our Veterans are "grateful" for everything we do is an understatement.

Some of our greatest achievements over the last several months have been providing loads of snacks and beverages, the Christmas Shoppe (donating over \$12,000 in retail), and the Valentine's party (with a DJ, food, games and cash prizes). Can you be-lieve Memorial Day is coming up? We've had some windy weather and



"All applicants for membership must fill out the <u>regular form</u> of membership application and, <u>in addition thereto</u>, present for examination by a duly qualified officer of the Post <u>or the Department</u>, either their <u>original discharge from service</u>, DD-214, a <u>certified or photo static copy of either</u>, or <u>proof of honorable service</u>."

To be Amended by: Removing the words "the regular form of", "in addition thereto", and " or the Department, either their original discharge from service, DD-214, a certified or photo static copy of either, or" So that when amended, Article IV, Section 4, shall read: All applicants for membership must fill out a form of membership application and present for examination by a duly qualified officer of the Post proof of honorable service.

PROPOSED AMENDMENT 25-CA-2

A proposed change to the Department Constitution, **Article IV**, **Section 6**, **which now reads**:

"No person who has been expelled by a Post shall be entitled to membership in another Post without the consent of the expelling Post, except that where such consent has been asked for and denied by such Post, that person may then appeal to the <u>Department Executive Committee</u> for permission to apply for membership in another Post and shall be ineligible for membership until such permission is granted."

To be Amended by: Removing the words "Department Executive Committee" and replacing with "Department Administrative Committee."

So that when amended Department Constitution, Article IV, Section 6, shall read: No person who has been expelled by a Post shall be entitled to membership in another Post without the consent of the expelling Post, except that where such consent has been asked for and denied by such Post, that person may then appeal to the Department Administrative Committee for permission to apply for membership in another Post and shall be ineligible for membership until such permission is granted.

PROPOSED AMENDMENT 25-CA-3

A proposed change to the Department Constitution, **Article VI**, **Section 3**, **which now reads**:

"The following special Department Officers are authorized but shall not serve on the Department Executive Committee: Department Communications Director, DMS Coordinator, Upper Peninsula Membership Coordinator, Assistant Membership Coordinator, Assistant Judge Advocate, Assistant Department Chaplain and Assistant Sergeants-at-Arms. The Officers may be appointed by the Department Commander, with approval of the Department Executive Committee. Department Veteran Affairs and Rehabilitation Director, with voice, but without vote, and Department Service Officers, who shall have neither voice or vote, are Department Officers per job description"

To be Amended by: Adding the words, "Assistant Adjutant" So that when amended, Article VI, Section 3 shall read: The following special Department Officers are authorized but shall not serve on the Department Executive Committee: Assistant Adjutant, Department Communications Director, DMS Coordinator, Upper Peninsula Membership Coordinator, Assistant Membership Coordinator, Assistant Judge Advocate, Assistant Department Chaplain and Assistant Sergeants-at-Arms. The Officers may be appointed by the Department Commander, with approval of the Department Executive Committee. Department Veteran Affairs and Rehabilitation Director, with voice, but without vote, and Department Service Officers, who shall have neither voice or vote, are Department Officers per job description.

PROPOSED AMENDMENT 25-CA-4

A proposed change to the Department Constitution, **Article VII**, **Section 2**, **which now reads**:

"Any group of qualified Veterans desiring to form a Post shall apply for the proper application blanks to the District Commander of the District in which such proposed Post is to be located; said proposed Post shall then get the approval of said District at a regular meeting with the required quorum present. <u>Upon District approval it shall then be the</u> duty of the Department Post Development Committee to examine the discharges of said applicants and to investigate their Charter and qualifications to determine their eligibility for membership. The Post Development Committee Chairman shall transmit to the Department Adjutant the completed application, certificate of eligibility, copy of the minutes of the District meeting giving its approval of said proposed Post, a written report of the Committee's investigations, and the Committee's approval or disapproval of the application. The application, upon approval of the Department Executive Committee, shall be forwarded to the National Headquarters. Upon approval by National Headquarters, a temporary charter will be issued."

To be Amended by: Removing the word, "blanks" and removing the sentence, "Upon District approval it shall then be the duty of the Department Post Development Committee to examine the discharges of said applicants and to investigate their Charter and qualifications to determine their eligibility for membership."

So that when amended, Article VII, Section 2 shall read:

Any group of qualified Veterans desiring to form a Post shall apply for the proper application to the District Commander of the District in which such proposed Post is to be located; said proposed Post shall then get the approval of said District at a regular meeting with the required quorum present. The Post Development Committee Chairman shall transmit to the Department Adjutant the completed application, certificate of eligibility, copy of the minutes of the District meeting giving its approval of said proposed Post, a written report of the Committee's investigations, and the Committee's approval or disapproval of the application. The application, upon approval of the Department Executive Committee, shall be forwarded to the National Headquarters. Upon approval by National Headquarters, a temporary charter will be issued.

PROPOSED AMENDMENT 25-CA-5

A proposed change to the Department Constitution, Article VII, Section 6, which now reads: "The Department of Michigan shall consist of all of the chartered Posts in the State of Michigan. Each Post may restrict its membership as it desires, subject, however, to the provisions of National and Department Constitution and Bylaws. Each Post may be restricted in number of members by the Department Executive Committee."

To be Amended by: Removing the sentence, "Each Post may be restricted in number of members by the Department Executive Committee." So that when amended, Article VII, Section 6, shall read:

The Department of Michigan shall consist of all of the chartered Posts in the State of Michigan. Each Post may restrict its membership as it desires, subject, however, to the provisions of National and Department Constitution and Bylaws.

PROPOSED AMENDMENT 25-CA-6

A proposed change to the Department Constitution, Article VII, Section 12, which now reads: "In addition to the newly elected Post Commander, each Post may select one (1) Delegate for each fifty (50) paid-up members, or major fraction thereof, to represent such Post at the annual Department Convention. Each Post may select an Alternate for each Delegate chosen. The Delegates and Alternates shall be chosen by each Post from among its own members in good standing. The names of all Delegates and Alternates shall be certified to the Department Adjutant no later than the close of business on the Friday before the opening date of the annual Department Convention."

To be Amended by: Add after Post Commander "or their designee." "Remove, "one (1) delegate for each fifty (50) paid up members, or major fraction thereof," Add "two (2) delegates" at the end of each Post may select, and add "for a total of three delegates."

So that when amended, Article VII, Section 12, shall read:

In addition to the newly elected Post Commander or their designee, each Post may select two (2) delegates for a total of three (3) to represent such Post at the annual Department Convention. Each Post may select an Alternate for each Delegate chosen. The Delegates and Alternates shall be chosen by each Post from among its own members in good standing. The names of all Delegates and Alternates shall be certified to the Department Adjutant no later than the close of business on the Friday before the opening date of the annual Department Convention.

PROPOSED AMENDMENT 25-CA-7

A proposed change to the Department Constitution, Article XI, Section 4, which now reads:

"Representation in the annual Convention shall be by Delegates and Alternates, duly elected by Posts of the Department and, in addition thereto, the Past Department Commanders and the members of the Department Executive Committee. with the exception of the Department Adjutant. Each of the above Delegates shall be entitled to one vote. Each Post having fifteen (15) or more paid-up members at the Department Headquarters thirty (30) days prior to the opening date of the PRIOR YEAR'S Convention shall have representation at the annual Convention on the basis of one Delegate for such Post, who shall be the newly elected Commander and one additional Delegate for each fifty (50) members or major American Legion and to promote the so-

Posts that have been chartered after the last Department Convention will have their delegate strength determined thirty (30) days prior to the next convention. Each Post represented at the Department Convention is entitled to cast the voting strength of its Post, provided all annual dues and debts to the District of which it is a part and the Department are paid." To be Amended by: Removing " Each of

the above Delegates shall be entitled to one vote. Each Post having fifteen (15) or more paid-up members at the Department Headquarters thirty (30) days prior to the opening date of the PRIOR YEAR'S Convention shall have representation at the annual Convention on the basis of one Delegate for such Post, who shall be the newly elected Commander and one additional Delegate for each fifty (50) members or major fraction thereof. Newly formed Legion Posts that have been chartered after the last Department Convention will have their delegate strength determined thirty (30) days prior to the next convention.

So that when amended, Article XI Section 4, shall read: Representation in the annual Convention shall be by Delegates and Alternates, duly elected by Posts of the Department and, in addition thereto, the Past Department Commanders and the members of the Department Executive Committee, with the exception of the Department Adjutant. Each Post represented at the Department Convention is entitled to cast the voting strength of its Post, provided all annual dues and debts to the District of which it is a part and the Department are paid.

PROPOSED AMENDMENT 25-CA-8

A proposed change to the Department Constitution, Article VII, Section 15, which now reads:

Post officers may be removed by the Post for cause on written charges of which the members of the Post shall be the sole judges. The procedure and right of appeal shall be the same as provided for members in Section 14 of this Arti-<u>cle</u>.

To be Amended by: Removing the words "provided for members in section 14 of this article" and Add "the appellate section of the Department Trial Procedures."

So that when amended, Article VII, Section 15, shall read:

Post officers may be removed by the Post for cause on written charges of which the members of the Post shall be the sole judges. The procedure and right of appeal shall be the same as the appellate section of the Department Trial Procedures.

PROPOSED AMENDMENT 25-CA-9

A proposed change to the Department Constitution, Article VIII, Section 1-7, which now reads:

Article VIII CITY AND COUNTY COUNCILS Section 1: There may be formed by the Posts of any County in this State, a County Council to carry out the principles of The

County Council. Section 3: All City and County Councils, when organized, shall adopt a Constitution and By-Laws effective only after approval of the Department Judge Advocate. An approved copy of such Constitution and By-Laws shall be filed in Department Headquarters.

Section 4: The Department Executive Committee may, upon recommendation of the Department Judge Advocate, suspend any provisions of the Constitution and By-Laws of a City or County Council, when in the judgment of such committee it contravenes the provisions of the National or Department Constitution and By-Laws or the established policy of the Department.

Section 5: Representation of the Posts in such County Council shall be on the same basis as such Posts had at the preceding Department Convention, or such other basis as said Council may decide.

Section 6: A City Council may be organized in any city having three or more Posts within its corporate limits, when a majority of such Posts so determine and by the same procedure as provided for the organization of County Councils. Such Posts may also belong to a County Council. No Post shall be compelled to join a City Council.

Section 7: No member Post of the County Council organization shall be liable to such County Council organization for more than the amount of the assessments stipulated in the By-Laws of such County Council organization. Member Posts shall not be liable for any of the debts and liabilities incurred by such County Council organization and for their protection and security may require the County Council organization to incorporate under the appropriate laws of the State as a condition precedent to continued membership therein.

To be Amended by: Removing the entire article and renumbering following articles. So that when amended Department Constitution,

So that Article VIII, Section 1-7, shall read: The article will be eliminated in its entirety.

PROPOSED AMENDMENT 25-CA-10

A proposed change to the Department Constitution, Article IX, Section 8, which now reads:

"Each District shall elect its District Commander by one of two (2) methods:

a) At a regular District Meeting to be held not less than ten (10) days nor more than one hundred twenty (120) days prior to the Annual Department Convention, using a method defined by the District Bylaws. Alternates shall be chosen at the same time and place as the District Commanders.

OR,

b) By vote of the Delegates representing Posts in the said District in attendance at the Annual Department Convention prior to the adjournment thereof, using a method defined by the Delegates in attendance. Alternates shall be chosen at the same time and place as the **District Commanders**.

c) If method in Paragraph A is used to elect the District Commander, method in Paragraph B cannot be used to override the election of a District Commander.'

To be Amended by: Replace "District Commander" with "District Officers" in all four locations of this Article and Section.

So that when amended, Article IX Section 8, shall read: Each District shall elect its District Officers by one of two (2) methods:

a) At a regular District Meeting to be held not less than ten (10) days nor more than one hundred twenty (120) days prior to the Annual Department Convention, using a method defined by the District Bylaws. Alternates shall be chosen at the same time and place as the District Officers. OR,

b) By vote of the Delegates representing Posts in the said District in attendance at the Annual Department Convention prior to the adjournment thereof, using a method defined by the Delegates in attendance. Alternates shall be chosen at the same time and place as the District Officers.

c) If method in Paragraph A is used to elect the District Officers, method in Paragraph B cannot be used to override the election of a District Officers.

PROPOSED AMENDMENT 25-CA-11

A proposed change to the Department Constitution, Article VII, Section 14, which now reads: Each Post shall be the judge of its own membership, subject to the restrictions of the National and Department Constitution and By-Laws; but no Post shall suspend or expel any member thereof, except upon charges duly brought in writing and after a full and fair trial, only upon the charge of "conduct unbecoming a member of The American Legion", of which said charges, the members of such Post shall be the sole judges; Provided, that an appeal from such Post decision may be taken to the Department Executive Committee by filing written reasons therefor with the Department Adjutant within thirty (30) days following final action by the Post. The decision of the Department Executive Committee shall be conclusive. The Department Executive Committee may formulate rules to govern the trial by a Post of any of the members thereof.

To be Amended by: Removing the entire section and replacing with Article IV Sections 1,2, & 3 of the National Bylaws. Section 1 of the National Bylaws to be numbered 14 and sections 2 & 3 to be numbered 15 & 16. Following sections to be renumbered accordingly.

Section 14. Each Post of The American Legion shall be the judge of its own membership, subject to the restrictions of the Constitution and By-Laws, except that no person who is a member of an organization which has for its aim the overthrow of the United States Government by force or violence, or who subscribes to the principles of any group opposed to our form of government, shall be eligible to become or remain a member of The American Legion.

Section 15. A Post may suspend or expel a Post member from The American Legion only after providing the member due process and a proper showing of cause. Charges shall be based upon disloyalty, neglect of duty, dishonesty and/or conduct unbecoming a member of The American Legion. All charges must be made under oath in writing by the accusers, and no member in good standing shall lose their membership until given a fair trial by the Post or Department in such manner and form as the Post or Department By-Laws and Post or Department Executive Committee shall prescribe.

Section 16. Any member who has been suspended or expelled has the right of appeal to

their Department Executive Committee, or to the Department Convention, according to the provisions in the By Laws of such Department. The decision of the Department shall be final.

PROPOSED AMENDMENT 25-CA-12

A proposed change to the Department Constitution, Article XI, Section 6, which now reads: "A majority vote shall be required upon all matters, unless otherwise specifically provided. The National Executive Committeeman, the Alternate National Committeeman and all elected Department Officers shall be elected by plurality vote if three (3) or more candidates run for any one position. Votes shall be recorded by Districts on all matters wherein a roll call shall be taken. Each District shall cast its vote in the manner to be provided by the rules of the Convention, but no Delegate shall be prevented by any rule from casting their vote as they so desire. Alternates may be seated with Delegates at the Department Convention. The Annual Convention shall authorize the appointment of such standing committees of this Department as it deems proper."

To be Amended by: Change standing committees to convention committees. Also adding "Executive" to Alternate Committeeman.

A majority vote shall be required upon all matters, unless otherwise specifically provided. The National Executive Committeeman, the Alternate National Executive Committeeman and all elected Department Officers shall be elected by plurality vote if three (3) or more candidates run for any one position. Votes shall be recorded by Districts on all matters wherein a roll call shall be taken. Each District shall cast its vote in the manner to be provided by the rules of the Convention, but no Delegate shall be prevented by any rule from casting their vote as they so desire. Alternates may be seated with Delegates at the Department Convention. The Annual Convention shall authorize the appointment of such convention committees of this Department as it deems proper.

PROPOSED AMENDMENT 25-CA-13

A proposed change to the Department Constitution, Article XII, Section 1, which now reads: "The elective Department Officers shall be chosen annually at the Department Convention by a roll call vote of the Districts of the Department, with the exception of the Zone Commanders, who shall be chosen at the "Zone" Caucuses by the Districts making up the "Zone" which that individual Zone Commander is to represent. Each Zone Commander so chosen must be and shall remain a member of a Post within their respective Zone or the office shall be declared vacant."

To be Amended by: Removing the words "roll call" and the sentence ". Each Zone Commander so chosen must be and shall remain a member of a Post within their respective Zone or the office shall be declared vacant."

So that when amended, Article XII, Section 1, shall read:

The elective Department Officers shall be chosen annually at the Department Convention by a vote of the Districts of the Department, with the exception of the Zone Commanders, who shall be chosen at the "Zone" Caucuses by the Districts making up the "Zone" which that individual Zone Commander is to represent.

PROPOSED AMENDMENT 25-CA-14

A proposed change to the Department Constitution, **Article XIII**, **Section 1**, **which now reads**:

"Between the Department Conventions, the executive, legislative, and judicial powers shall be vested in the Department Executive Committee which shall be composed of the following: Department Commander, Department Vice Commanders, District Commanders, Department Finance Officer, Department Judge Advocate, Department Historian, Department Chaplain, Department Sergeantat-Arms, immediate Past Department Commander, National Executive Committeeman, all with vote, and the Department Adjutant, who is without vote. Each member of the Department Executive Committee shall be entitled to one (1) vote. In the absence of a District Commander such vacancy shall be filled by their Alternate District Commander and in the absence of the National Executive Committeeman such vacancy shall be filled by the Alternate National Executive Committeeman.

To be Amended by: Add "Zone Commanders," Remove "their Alternate District Commander," and replace with "an Alternate" and moving "Judge Advocate" from the current location to after Department Adjutant adding the word "and" in front of "Judge Advocate" and changing "who is without vote" to "who are without vote."

So that when amended, Article XIII, Section 1, shall read:

Between the Department Conventions, the executive, legislative, and judicial powers shall be vested in the Department Executive Committee which shall be composed of the following: Department Commander, Department Vice Commanders, Zone Commanders, District Commanders, Department Finance Officer, Department Historian, Department Chaplain, Department Sergeant-at-Arms, immediate Past Department Commander, National Executive Committeeman, all with vote, and the Department Adjutant and Department Judge Advocate who are without vote. Each member of the Department Executive Committee shall be entitled to one (1) vote. In the absence of a District Commander such vacancy shall be filled by an Alternate and in the absence of the National Executive Committeeman such vacancy shall be filled by the Alternate National Executive Committeeman.

PROPOSED AMENDMENT 25-CA-15

A proposed change to the Department Constitution, **Article XIV**, which now reads:

"Section 1: The American Legion, Department of Michigan recognizes an Auxiliary organization, known as the American Legion Auxiliary, Department of Michigan.

Section 2: Membership in the Auxiliary shall be prescribed by the National Constitution of The American Legion Auxiliary.

Section 3: The Auxiliary shall be governed by such rules and regulations as may be prescribed by the National Executive Committee and thereafter approved by The American Legion, Department of Michigan.

Section 4: In the absence of rules and regulations governing the Auxiliary, promulgated by the National Executive Committee, the Department Executive Committee may provide for the organization and administration of Auxiliary units within the Department."

To be Amended by: Deleting Sections 2,3, and 4 in their entirety.

So that when amended, Article XIV, shall read: Section 1 only.

PROPOSED AMENDMENT 25-CA-16

A proposed change to the Department Constitution, Article XVI, Section 4, which currently does not exists:

The Second (2nd) Vice position will be filled by the Department Executive Committee.

"The Department Executive Committee may, by twothirds (2/3) vote of all of its members, remove from office any officer or committee member of the Department for malfeasance, misfeasance, or nonfeasance in office or for conduct unbecoming a member of The American Legion. Complaints seeking removal of such officer or committee member shall be reduced to writing, signed by a member of the Michigan Department and verified by oath that the charges therein contained are true of the member's own knowledge. Such complaint shall be immediately referred to the Department Administrative Committee, which shall cause the matters therein set forth to be investigated by the Department Judge Advocate, unless the Judge Advocate be an interested party or necessary witness, in which case the Department Commander or the Department Administrative Committee shall appoint a special Judge Advocate for such purpose. The Department Judge Advocate shall cause a copy of the complaint to be sent by registered letter to the official address of the accused and shall afford the accused opportunity to reply thereto. The result of such investigation shall be reduced to writing and promptly returned to the Department Administrative Committee, with the recommendation of the Department Judge Advocate endorsed thereon. Unless the Department Administrative Committee shall, by a four-fifths (4/5) vote of all the members, find the complaint to be without merit, the matter shall be referred to the Department Executive Committee. It shall be the duty of the Commander to forthwith call a special meeting of the Department Executive Committee to convene within twenty (20) days thereafter to consider and act upon the complaint. Upon failure of the Department Commander to call such a meeting within a period of five (5) days after the complaint shall have been referred to the Department Executive Committee by the Department Administrative Committee, any other officer of the Department shall be authorized to call such meeting. The Department Executive Committee shall, by resolution, determine the manner in which such complaint shall be heard and action taken thereon. The action of the Department Executive Committee shall be final and conclusive."

To be Amended by: Remove in its entirety and replace with "Discipline shall be as outlined in the Department Disciplinary Procedures as approved by the Department Executive Committee."

So that when amended, Article XI Section 1, shall read: Discipline shall be as outlined in the Department Disciplinary Procedures as approved by the Department Executive Committee.

PROPOSED AMENDMENT 25-CA-38

A proposed change to the Department Bylaws, **Article XII**, **Section 4**, **Currently does not exist**

To be Amended by: Adding, "Section 4: All amendments approved by the delegates of a convention shall take effect at the close of the convention unless otherwise stated by the amendment."

So that when amended, Department Bylaws, Article XII, Section 4, shall read: Adding, Section 4: All amendments approved by the delegates of a convention shall take effect at the close of the convention unless otherwise stated by the amendment.

PROPOSED AMENDMENT 25-CA-39

A proposed change to the Department Bylaws, Article IV, Section 5, which now reads: "Each Post shall be the judge of the qualification of its members provided such members are eligible for membership in The American Legion, and each Post may set such other reasonable standards of qualification for membership as it may determine. Race, religion, sex, creed, or national origin shall not be a barrier to membership."

To be Amended by: Inserting "and shall judge the new membership application or existing member transfer based on each posts' own constitution and by-laws, notifying the Department of all rejected members and the cause within 45 days of receiving all applications."

So that Article IV, Section 5 , shall read: Each Post shall be the judge of the qualification of its members and shall judge the new membership application or existing member transfer based on each posts' own constitution and by-laws, notifying the Department of all rejected members and the cause within 45 days of receiving all applications and provided such members are eligible for membership in The American Legion, and each Post may set such other reasonable standards of qualification for membership as it may determine. Race, religion, sex, creed, or national origin shall not be a barrier to membership

PROPOSED AMENDMENT 25-CA-40

A proposed change to the Department Bylaws, **Article IX, Section 9, which now reads:**

"Each District Commander shall hold office from the close of one Department Convention until the close of the next Annual Department Convention; provided, however, that a District Commander shall hold office only during such term as their membership remains in the District from which they were elected. A vacancy in the office of District Commander shall be filled by the Alternate, and a new Alternate shall be selected in accordance with the District Association By-Laws."

To be Amended by: Removing "provided, however, that a District Commander shall hold office only during such term as their membership remains in the District from which they were elected. A vacancy in the office of District Commander shall be filled by the Alternate, and a new Alternate shall be selected in accordance with the District Association By-Laws."

So that Article IX, Section 9, shall read: Each District Commander shall hold office from the close of one Department Convention until the close of the next Annual Department Convention.

PROPOSED AMENDMENT 25-CA-41

A proposed change to the Department Bylaws, Article XI, Section 2, which now reads:

"Notice shall be given of the Annual Department Convention by the Department Adjutant to all Posts of the Department of the time and place of the Convention, which notice shall be entitled "Call of the Annual Convention", and which shall be published electronically on the Department website at least sixty (60) days prior to said Convention and be published in paper form in a spring edition of the Michigan

Legionnaire. There shall be no other official notice of the Department Convention."

To be Amended by: Removing "in paper form" So that Article XI, Section 2, shall read: Notice shall be given of the Annual Department Convention by the Department Adjutant to all Posts of the Department of the time and place of the Convention, which notice shall be entitled "Call of the Annual Convention", and which shall be published electronically on the Department website at least sixty (60) days prior to said Convention and be published in paper form in a spring edition of the Michigan Legionnaire. There shall be no other official notice of the Department Convention.

PROPOSED AMENDMENT 25-CA-42

A proposed change to the Department Constitution, Article VI, Section 2, which now reads:

"The Executive Committee of the Department shall consist of the Officers of the Department, the Immediate Past Department Commander and National Executive Committeeman, together with Zone Commanders, District Commanders, as hereinafter provided. The Department Commander shall serve as the Chairman of the Department Executive Committee."

To be Amended by: Adding the words "All Past Department Commanders"

So that when amended Department Constitution, Article VI, Section 2, shall read:

The Executive Committee of the Department shall consist of the Officers of the Department, the Immediate Past Department Commander and National Executive Committeeman, together with All Past Department Commanders, Zone Commanders, District Commanders, as hereinafter provided. The Department Commander shall serve as the Chairman of the Department Executive Committee.

PROPOSED AMENDMENT 25-CA-43

A proposed change to the Department Constitution, Article VI, Section 4, which now reads:

"All Past Department Commanders, other than the Immediate Past Department Commander, as noted in Section 2 of this Article, shall be ex-officio members of the Department Executive Committee with voice, but without vote and without expenses for so long as they remain a member in good standing of a duly chartered American Legion Post in the Department of Michigan. They shall be accorded all the courtesies of the floor of the Department Executive Committee, with the privilege of making and seconding motions and of speaking on any motion or subject before the Department Executive Committee but shall have no right to vote."

To be Amended by: Removing Article VI, Section 4 **So that when amended** Department Constitution, Article VI, Section 4, shall be eliminated.

PROPOSED AMENDMENT 25-CA-44

A proposed change to the Department Constitution, **Article V, Section 1**, which now reads:

"Department Commander shall be the Chief Executive Officer of the Department and shall be empowered and directed to do such acts as may be necessary and proper to conduct the business of the Department. The Department Commander shall preside at the Annual Convention and at all meetings of the Department Executive Committee and shall issue all necessary orders and may direct the Adjutant or any other Department Officer, when necessary, to proceed to any place on American Legion business. The Department Commander shall appoint all standing committees, subject to approval of the Department Executive Committee, except as otherwise provided. The Department Commander shall represent the Department in all of its relations with the federal, state and local government and with the people of the State of Michigan. The Department Commander shall see that all provisions of the National Constitution and Bylaws and all policies established under them are duly observed. The Department Commander shall be reimbursed up to the budget allowance for necessary actual travel expenses while in performance of the duties of the office, with any additional funding to be determined by the Finance/ Personnel Committee, subject to the approval of the Department Executive Committee. No persons shall be eligible for re-election to the office of Department Commander."

To be Amended by: Removing "No persons shall be eligible for re-election to the office of Department Commander." Replacing with" and shall not serve more than one (1) consecutive term." So that when amended, Article V, Section 1, shall read: Department Commander shall be the Chief Executive Officer of the Department and shall be empowered and directed to do such acts as may be necessary and proper to conduct the business of the Department. The Department Commander shall preside at the Annual Convention and at all meetings of the Department Executive Committee and shall issue all necessary orders and may direct the Adjutant or any other Department Officer, when necessary, to proceed to any place on American Legion business. The Department Commander shall appoint all standing committees, subject to approval of the Department Executive Committee, except as otherwise provided. The Department Commander shall represent the Department in all of its relations with the federal, state and local government and with the people of the State of Michigan. The Department Commander shall see that all provisions of the National Constitution and Bylaws and all policies established under them are duly observed. The Department Commander shall be reimbursed up to the budget allowance for necessary actual travel expenses while in performance of the duties of the office, with any additional funding to be determined by the Finance/ Personnel Committee, subject to the approval of the Department Executive Committee and shall not serve more than one (1) consecutive term.



We have completed The American Legion Department of Michigan's tool that will let all our American Legion Family help us pass legislation that will help veterans and their families. The process is much like National's "Legislative" Alert System." The steps to become involved are as follows:

- 1. Go to the Department website at HTTP://MichiganLegion.
- 2. From the home page, scroll down to "2025-2026 Legislative Priorities" and click to open it.
- 3. Once on the priorities page, click on one for more informa-
- 4. If you agree with that priority, click NEXT, and you will be asked for your contact information. If your information remains the same the next time you sign in, all you will have to do is provide the email that you used the first time you entered your information.
- 5. CLICK NEXT, and your email will be sent to your elected officials based on your zip code. You will then get a confirmation
- 6. When we get notice that a bill supporting one of our priorities has been authored, you will be notified via email. With a click, you will send a new email to your elected officials asking them to support the bill.

We look forward to all our Family, American Legion, Auxiliary, Sons, and Rider's members using this new system, and even if your family or friends wish to use it and support our efforts to make life better for all Veterans in Michigan, please have them do so.






