Veterans Affairs & Rehabilitation

The foremost pillar of American Legion service, learn the ways in which the organization is dedicated to compassionate care, timely delivery of benefits, career development and other areas of advocacy for those who have served in uniform.

National Security

Outlined here is The American Legion's position on a strong, well-equipped and effectively deployed U.S. military, including a decent quality of life for those now in uniform and retirees of the Armed Forces.

Americanism

This pillar of American Legion service is marked by respect for the nation that those in the military swore to defend with their lives, from proper treatment of the U.S. flag to voter education and youth programs that make life-changing differences.

Children & Youth

The American Legion's long-held position that "every child deserves a square deal" is explained here, to include such programs and efforts as the Child Welfare Foundation, the Family Support Network, Temporary Financial Assistance and other initiatives that aim to help children and youth follow their dreams, no matter their circumstances.

TOPICS OF CONCERN **Brett Holt, Judge Advocate**

Happy Veterans Day and Thanksgiving to all the Michigan American Legion family!

This article is a **do-not-do** list. Please pay attention to the list. It will help you know where to go and what to do, and reduce

frustration for everyone.

1. The Post Lounge/Bar belongs to the post as a fundraiser. The Liquor license is issued to the post, not the district or department. The district and department cannot and will not intervene in bar business. If you have accounting issues, contact an accountant; if you have legal issues, contact an attorney. If someone is acting in an improper manner, have them leave. If the conduct rises to the level of a civil or criminal issue, contact the authorities.

Suppose you have been suspended by the post from the lounge or bar, that is an internal issue. Check your post Bylaws and Bar rules to determine if there is an appeal process. Again, the district and department will not intervene in

bar issues.

If someone is suspended from the bar, it means exactly that: the bar. A bar suspension does not equate to a post suspension. The member still has all the rights of a member, including attending meetings and events.

4. If the member's conduct rises to the point of the post wanting to take additional action, then file a formal complaint using the Trial Procedures of the Department of Michigan and allow the member the due process they deserve.

- 5. If a civil or criminal complaint has been filed against the member, the post should not take any additional punitive action against the member until the civil or criminal action is complete.
- 6. If the officers of the post are concerned about the safety of members while criminal or civil charges are pending, then they should use the legal system to file for a restraining order. Again, you cannot prevent a member from attending meetings and events without due process. A restraining order is a legal order that overrides the rule.

7. If you have questions about procedures of any sort,

contact your Post Commander, Adjutant or Judge Advocate. If they cannot assist, then contact your District Commander, Adjutant or Judge Advocate. If they cannot assist or if they are part of the issue, then you may contact Department. If you contact me before going through the other steps, I will refer you back to them.

8. Do not contact the National Office. They will simply refer the issue back to the department. Department, in turn,

will refer the issue back to the district.

9. Check your Constitution and Bylaws or Post Standing Rules before contacting any higher authority. I do not have a copy of every post Constitution and Bylaws on hand and cannot tell you what yours directs your post to do.

10. If you make changes to your Constitution and Bylaws, follow the requirements of your current Constitution and Bylaws. The new Constitution and Bylaws, as well as a copy of the minutes showing the post-vote on the changes, must be sent to Department. They are not valid or in effect until the

Department Judge Advocate has approved them.

On another note, the NEC at the National Fall Meetings received a Legal Opinion on whether or not Sons of the American Legion are members of the post. The National Judge is of the opinion that the SAL are not members of the post as they are a program and are not afforded all of the privileges of veteran members. The opinion is based on IRS requirements. Each Department will have to determine the relationship between the organization, the IRS, the State Liquor Control Commission and possibly other entities.

This opinion pertains solely to the IRS and the distinction between taxable and non-taxable income. The Judge's Opinion states that SAL members must either be signed in as guests or a separate account must be kept when making sales to SAL members, as income from sales to SAL mem-

bers would be considered taxable.

Please remember this is an opinion and not a ruling. Nonetheless, your post must decide how to proceed until the Department can get further clarification for you. I will have additional information on this issue in the next Michigan Legionnaire.

It is not a formal program or a onetime event; it's an ongoing commitment to guide, support, and invest in one another.

If every leader in our Department commits to this simple practice, we will not only improve our retention, but we will also create a vibrant, forward-looking organization where every member sees a future for themselves in The American Legion. This is how we move from surviving to thriving.

Supporting Adaptive Sports for Veterans

Welcome to November! A time to celebrate our Veterans and to be thankful for the people and things in our lives. First, let me express my gratitude to the chairpersons who gave presentations at the fall confer-

ence. What a fantastic job they did of instructing the members and officers in attendance. Thank you to the crew who decorated the room with "Mission Possible." Those secret agents did a fabulous job. I hope you have all gone back to your Units and Districts to teach and mentor the membership. We will succeed because of YOU.

My Special Project. Did you know that the U.S. Department of Veterans Affairs Health Care system treats over 94,000 Veterans with at least one amputation? Between 2009 and 2019, there was a 34% increase in Veterans with amputations. Most of the amputees who served before the Global War on Terror have amputations due to medical conditions. For GWOT Veterans, a large proportion has resulted from combat operations.

Losing a limb or more can have a devastating effect on the body and mind. Or losing the ability to walk again, confined to a wheelchair, can create a life of isolation and depression.

My special project focuses on supporting the area of

"Adaptive Sports for Veterans." The VA and nonprofits look for ways to assist Veterans with amputations, blindness, or other physical disabilities, so that they can participate in sports, such as downhill skiing, golf, ice hockey, cycling, or a variety of different activities.

Will you help me raise awareness and support for this endeavor? If you haven't heard of adaptive sports, the department has created a webpage at www.michalaux.org/sp to tell you more about it. I do not have a particular organization in mind yet. However, all proceeds raised will go to helping an organization or Veterans who need help so they can participate. The goal is to show as many Veterans as we can that they can participate.

JUNIORS ACTIVITY PROGRAM

This year, we are making a concerted effort to revitalize our Junior Program. We need to know if there are any Juniors interested in running for Honorary Junior Officers for 2026-2027. If we have enough interest, we might be able to plan to have a Junior Convention in the spring.

At the unit level, honorary Junior

officers traditionally include president,

vice president, chaplain, historian, secretary, treasurer, and sergeant-at-arms. The designation of Honorary Junior officers depends on the organizational

structure of the unit. Honorary Junior offices are purely honorary, courtesy positions without any formal duties or assignments. If you have enough Juniors, plan an election of honorary Junior officers. You do not have to fill every office. It is helpful if you explain that holding office is a responsibility rather than a chance to be "in charge." Leaders help set directions, get things going, encourage members to work together, invite new people to be involved, and help the group celebrate its accomplishments. The basic roles you need to start are a president, a secretary, and a chaplain at your Unit level. Open the meeting in normal fashion. Thank the girls for coming. Hold your election for the honorary Junior Officers. Once elected, assist the new Junior President in running the remainder of the election. Even if you have only two candidates, hold the meeting. It is important to let them know they are wanted, and you are glad they came. The senior counterpart for each Junior officer could read the charge to the Junior and pledge their support. Once the meeting is complete, have special refreshments to congratulate the new officers. You could ask some of the senior members to provide them. It is a great way to get the Juniors to attend the meeting and to get the seniors involved. Be sure you have set the time, location, and date of your next meeting

If you have difficulty getting girls to attend meetings, be flexible. Youth are remarkably busy now. Be willing to hold your meeting on a different night or at a different time. Running into trouble planning projects for the girls? Ask them if they have any ideas for a community project. A dinner fundraiser for a friend or family member, cleaning a park or playground, providing school supplies for those less fortunate, or providing necessities for veterans in hospitals. The possibilities are endless. If the girls are helping, they are happy and engaged. Do not give up. It may take several meetings to get more girls involved. Be persistent; any action at all is progress.

Our Department President, Dawn Gramza, would like all the Juniors in our state to make or sign "Thank You Cards for our Veterans." This can be done at any Unit with Juniors. You can bring them to the Fall Conference, mail them to the Department, or to either Sheila or me. This is something that all our Juniors can do, no matter what their age is. Americanism should be a major focus for Juniors and helps teach patriotism, citizenship, and loyalty to American ideals and principles.

I want to thank Sheila for all her help at the Fall Conference, and all the members who helped with some ideas on what we can do to help get our Honorary Junior Officers back.

Best Practices that Make It Possible to Complete Our Mission



There are certain activities and actions that you can take as members to make sure we have a Mission Possible at Headquarters. We all want to work smarter-not harder. Following are the situations we see most often:

Please only send one check per transmittal-this ensures proper accounting and record keeping. There is Shannon Werner no reason to send your complete ros-Executive Director, ter every time you turn in a transmittal, Secretary-Treasurer please use the transmittal list provided in your membership packets. You can

also print this form (and many others) from our website (www.michalaux.org), or you can place a supply order and we will happily send you some.

If you are paying for multiple dues years (and amounts) please separate the differing dues years and provide them on separate transmittals. Each transmittal should have its own year and its own check. This will eliminate errors in the payment of correct dues years to National as well as the information input to our accounting sys-

Do not send copies of DD214's or any other personal information related to prospective members. We do not require multiple copies of any paperwork. When you have a member that is transferring, we do not need a copy of their card. When we lose a member, we do not need a copy of their membership card. When you send documentation and/or information to headquarters, make sure it is clearly marked and noted as to the intention. le: transmittals, donations, ALAMIS access,

supplies, etc.

In case you didn't know, National creates the membership cards and pulls your roster for unit member-ship packets in April each year. If a member has not renewed by April, they will not appear on your roster or have a membership card printed and provided by National. Do your best to get your membership paid prior to April 1 every year. Members can print their own card from the www.alaforveterans.org website after they create an account. You can also order membership cards from National or send in a supply order form with your check and we can mail you blank cards (blank except for the year).

When you need contact information for our Leadership representatives or Program Chairman, go to our website at www.michalaux.org. Each Chairman has a program guide that contains the information you require. If you have questions regarding ALAMIS you can email alamishelp@alaforveterans.org Don't forget the ALAMIS renewal period is approaching quickly-No-

vember 1 to January 6.

If you haven't seen it already, take the time to watch the Paperwork 101 Training located on our website, it has all the information you need to be a successful membership chair. The direction(s) given in the training replaces all instructions and guidance you may have received in the past.

Parliamentary Procedure and Parliamentarians: Keeping Our Mission on Track

Every decision we make, whether it's about funding a program, planning an event, or electing board members should reflect our mission and values. That's why parliamentary procedure is so important. It helps us make decisions fairly, efficiently, and with respect for all voices. And when things get complicated, parliamentarians help guide the way.

What Is Parliamentary Procedure and why do we use it? Parliamentary procedure is a set of established rules used to run meetings in an orderly and democratic way. You may have heard of Robert's Rules of Order, it is the most commonly used

rulebook for nonprofits like ours.

Using parliamentary procedure ensures that every member has the right to speak and be heard, the majority makes decisions, but the minority's rights are protected; meetings stay focused and productive, and voting and motions are handled clearly and correctly. In short, it's about respect for the process, for each other, and for the mission we serve.

Who Are Parliamentarians and What Do They Do? A parliamentarian is someone trained in the rules of order. Their job is to support our leadership and members by advising the board chair or committee leader during meetings, helping write or revise bylaws and policies, training members to participate more effectively, assisting with votes, elections, and amendments, ensuring we follow both our internal rules and legal requirements.

Some parliamentarians are certified professionals, while others may volunteer their expertise in organizations like ours where service and stewardship matter. Our members know the value of discipline, teamwork, and respect. Parliamentary procedure builds on those same principles. It promotes unity by giving everyone a fair voice, maintains focus, even when conversations get emotional or complex, it protects trust ensuring decisions are made transparently and correctly, and it upholds integrity, so that our mission always comes first.

Whether we're deciding how to honor fallen comrades, supporting a veteran in crisis, or funding a new program, structure

and fairness matter.

Common Misunderstandings Cleared Up

How often have we heard "It's too complicated." The basics are easy to learn and we can train you! Think of it as a mission briefing for your meeting. "We're too small for this." Even a three-person committee benefits from having clear rules. "The parliamentarian runs the meeting." The chair runs the meeting. the parliamentarian is there to quietly support and guide, not to take over.

Veterans understand what it means to serve with honor and discipline. Bringing that same spirit into our organizational meetings helps us be more effective, respectful, and mission-focused. Whether you're a board member, volunteer, or staff leader, learning and using parliamentary procedure ensures our nonprofit runs with integrity—and stays true to the veterans we serve.

When in doubt, don't guess—ask a parliamentarian.

This year our Auxiliary President, Dawn Gramza's special project is Adaptive Sports. Adaptive Sports, commonly known as Paralympic Sports or Disability Sports, have been modified to allow individuals with disabilities, such as veterans, to participate in sports activities. The range of sport activities can be from traditional wheelchair basketball and wheelchair tennis to more specialized sports like goalball (a specifically designed sport for individuals who are blind or visually impaired).

The origin of adaptive sports can be traced back to the aftermath of World War II, when large numbers of soldiers returned home with disabilities. Rehabilitation programs were developed to help these individuals regain their physical and mental strength, which often included sports and physical activities. As a result, the first adaptive sport organizations were formed.

As adaptive sports has evolved so have the types of equipment used by these athletes. Wheelchairs have been used for centuries, but it wasn't until the 1950's when they were designed of lighter weight materials and specialized brakes allowing the athletes to participate in a wider range of sports. There have been other innovations such as prosthetic devices and equipment like goalball and blind soccer for those who are visually impaired. There is also volleyball, sitting rugby, adaptive sailing, kayaking, sledge hockey, para-alpine skiing basketball and martial arts.

How can we help? Organize events such as a charity run, auction, bake sales, direct donations of funds, contribute equipment (wheelchairs, bikes, or special gear) to local organizations, or have an equipment drive to collect gently used or new sports equipment for veterans.

In conclusion, adaptive sports play a crucial role in the lives of veterans in Michigan, offering opportunities for physical activity, social engagement, and personal development. As the state continues to support these initiatives, the impact on veterans' health and well-being will undoubtedly grow, proving that sports can be a powerful tool for healing and reintegration. By participating in or supporting adaptive sports programs, we can help our veterans thrive in both body and spirit.

Here are a few ways that may help in retaining your members and easing that struggle. Have a program not a campaign, retention is a year-around priority and needs to be planned. Have a retention committee with goals. When you send out renewal notices include a return envelope or even a postage paid envelope if your Unit has the funds. Send the renewal notice in the form of an invitation: "President (name) requests the honor of another year as your partner in advancing our organization."

Be sure to acknowledge renewals just like new members, with a note of thanks from the President and Membership Chairman. This could be mailed with the membership card. Give discounts or prizes for early renewals. Encourage members to participate in your Unit activities. Example-my unit pays the next years dues for a member who participates/volunteers for 7 of our unit events. Give out lapel pins and certificates for continuous year membership starting at 5 year increments. Have interesting meetings, not too long, laugh some, sing a song. Have a door prize drawing at each meeting, have an ugly Christmas sweater contest.

Get members involved at SOME level "Involved" members do not drop out. Utilize the National website for additional ideas, renewal templates and much more.

Did you know that if a student you sponsor indicates on her ALA Girls State application that she is a descendent of a Veteran, she is not only eligible to apply for our Samsung Scholarship, she is also eligible to join your American Legion Auxiliary Unit? Expand your membership numbers by inviting your ALA Girls State delegates and their family members to fill out a membership application. Our communities need our youth to continue our mission of serving veterans, military,

and their families.

In closing, our program is an amazing week of learning, focused on responsible citizenship and leadership. Chaplains Corner Mike Schlaack, Dept. Chaplain

"Don't shoot the messenger!" I am sure we have heard that phrase before, and maybe even used it a few times ourselves. No one likes to be the bearer of bad news just as much as no one wants to hear it, but some-

times it is necessary to warn others of an impending event that could affect their lives. While the message may not be pleasant to hear, it may be worth heeding, and eliminating the

messenger will not change the outcome.

Recent events have drawn our attention to the impact the spoken word has on those who do not agree with the message being delivered. Rather than agreeing to disagree in a thoughtful, peaceful manner, some find it necessary to resort to violence, directing their hatred of the message to the messenger himself. And while there has been an uptick in this sort of reaction in public discourse, we should remember that it is nothing new. People have been "shooting the messenger" since the beginning of recorded time.

Back in the 6th century B.C., a prophet named Jeremiah told of the impending capture of Jerusalem by the Babylonians. Jeremiah's message to the king was to surrender to the attackers to save the city and the lives of its inhabitants. The officers of the army defending Jerusalem asked the king to put Jeremiah to death, since his message of capitulation was causing morale problems amongst the soldiers. To silence the messenger, Jeremiah was placed in a muddy well (Jeremiah 28:1-6). However, the truth could not be changed by silencing the messenger, and Jerusalem did fall to the Babylonians; the city was destroyed, and its inhabitants were carried off into captivity (52).

Even earlier, in the 8th century B.C. the Prophet Jonah was directed by God to preach to the inhabitants of the great city of Nineveh, foretelling its destruction because of their sinful ways (Jonah 1:1). After a perilous journey (and three days in the belly of a huge fish), Jonah arrived in Ninevah and preached the message as directed by God. Hearing of the impending destruction of the city and its inhabitants due to their wickedness could not have been a pleasant message for the king and the city's inhabitants to hear. But this time, instead of silencing the messenger, the king of Nineveh heard the words of God, ordered everyone to repent in "sackcloth and ashes" (3:7), and as a result, the city and its inhabitants were saved by obeying God as proclaimed by Jonah (3:10).

Sometimes, for our own good, we need to hear the uncomfortable messages being broadcast in our public spaces, and silencing the messenger will never change the importance or the results, and may, in fact, amplify the words. Open, public debate is one of our cornerstone freedoms as Americans, and so is our right to accept or reject the message as well as the messenger respectfully and peacefully. Each of us must do

our part to help restore civility in public discourse.

2026 Dues Direct Program

The Dues Direct program frees your post officers from the renewal receipt and fulfillment process, which can be time-consuming. The membership records are usually updated much faster, which also reduces the number of renewal notices that need to be mailed. The processing cost is currently only \$0.83 per renewal, which includes the cost of postage. As you know, postage is already up to 76 cents per stamp. This is a no-brainer for a large post! In fact, over 5000 post-225 members' dues are processed in this manner.

Briefly, when renewal notices are mailed to your Post members, the return reply is sent directly to National Headquarters for processing. Members also have the option of renewing online through a special website. National processes the renewal payment, updates the membership record, and forwards the member their new membership card, which also includes our Department's contact information.

Investing in Michigan's Youth: Encourage Students to Apply for 2026 Legion Scholarships Larry Money, Education and Scholarship Committee Chairman

As Legionnaires, one of the most meaningful ways we can continue our mission of "For God and Country" is by supporting the next generation through education and opportunity. The American Legion, Department of Michigan, is once again offering several scholarship and youth programs for the 2025–2026 year and we need your help spreading the word.

Members are encouraged to reach out to local high schools, youth organizations, and community programs to share these opportunities. Whether it's a student with a passion for public speaking, a young person pursuing higher education, or someone learning a skilled trade, the Legion has a program designed to help them achieve their goals.

The Oratorical Scholarship Program, "A Constitutional Speech Contest," gives high school students the chance to strengthen their leadership and public speaking skills while deepening their understanding of the U.S. Constitution. The Department contest will take place Saturday, March 28, 2026, at the Michigan Historical Museum in Lansing, with scholarships ranging from \$1,000 to \$2,000. The department winner will advance to the national contest, where prizes reach up to \$25,000. Registration closes December 5, 2025.

Two additional scholarships honor the service and sacrifice of our veterans and their families. The William D. & Jewell Brewer Scholarship (\$500) and the Guy M. Wilson Scholarship (\$1,000)

are awarded based on academic performance, leadership, and financial need. Both are open to Michigan residents who are direct descendants of an honorably discharged veteran or active-duty service member. Applications must be received by January 5, 2026, at 5:00 p.m.. Students may apply for one or both, but only one award will be granted per recipient.

Finally, the Skilled Trades Scholarship provides two \$1,000 twoyear awards for Michigan residents aged 17–21 who are pursuing a trade or technical career in fields such as construction, automotive, energy, or advanced manufacturing. This scholarship helps cover expenses like tools, tuition, and safety gear ensuring that students pursuing hands-on careers have the resources they need to succeed. Applications are due by April 3, 2026.

Every year, these programs make a lasting difference in the lives of Michigan students and your outreach can help us reach even more of them. Please take a moment to share these opportunities with local schools, counselors, and families. Together, we can inspire young citizens to pursue their goals, serve their communities, and carry forward the values we uphold as members of The American Legion.
